Elementary Principal Brown noted that the 2nd grade position has been filled, summer school dates are finalized, there was 98% attendance for parent-teacher conferences, Librarian Sarah Holub ran the book fair both nights, the Walkathon is May 10th, ISASP is coming up April 8-12, and he has a new baby coming soon and will be out for paternity leave the beginning of April.

Athletic Director Horman reported that State Wrestling finishing in 8th place, Boys and Girls Basketball had good seasons, we have HS Girls Wrestling with Mt Vernon and JH Girls Wrestling here, both HS and JH Boys and Girls Track have good numbers, Golf started practice today, Mt. Vernon Girls join us for Golf, we have students that go to Mt. Vernon for Soccer, Jazz Band has qualified for the State festival in Ames, Drama will be performing the musical Little Women in April, and we had a HS Dance Showcase last month which was great.

Superintendent Pino noted that we will not have any snow make-up days, there is no school on Good Friday, she is having meetings regarding internal and external doors and key access, she is working with the Police Department and Nurse Julie Light regarding safety scenarios, SIAC graduate and broader vision conversations are taking place, and she's working with LECC leadership staff on team, culture, and vision.
